Oct. 1 First day to file 2021-22 Free Application for Federal Student Aid (FAFSA).

Nov. 1 KCC Foundation Scholarship applications for the 2021-22 award year available online at www.kcc.edu/scholarships.

March 1 Scholarship application deadline for KCC Foundation awards for 2021-22 award year.

June 18 Priority date: Required documentation for grant or loan assistance must be completed and submitted to avoid being dropped at the July 29, 2021 fall preregistration payment date.*

July 29 Fall preregistration payment due date.

Sept. 3 Fall 2021 Financial Aid Eligibility date – be enrolled for all fall courses, including 8-week and late starting, by this date.

Sept. 17 Last day to purchase all books and supplies in the bookstore using an eligible PELL grant or loan, including all 8-week and late-starting fall classes.

Sept. 29 Fall 2021 PELL grants, SEOG and loans disbursed to qualified students with completed files and activated awards.

Oct. 1 First day to file 2022-23 Free Application for Federal Student Aid (FAFSA) - www.fafsa.gov

Oct. 27 Fall 2021 PELL grants, SEOG and loans disbursed to qualified students with completed files and activated awards.

Nov. 5 Priority date: Required documentation for grant or loan assistance must be completed and submitted to avoid being dropped at the Dec.3, 2021 spring preregistration payment date.*

Nov. 5 Last day to apply for a Fall 2021 loan.

Nov. 17 Fall 2021 PELL grants, SEOG and loans disbursed to qualified students with completed files and activated awards.

Dec. 3 Spring preregistration payment due date.

Jan. 28 Spring 2022 Financial Aid Eligibility date - be enrolled for all spring courses, including 8-week and late starting, by this date.

Feb. 11 Last day to purchase all books and supplies in the bookstore using an eligible PELL grant or loan, including all 8-week and late-starting spring classes.

Feb. 23 Spring 2022 PELL grants, SEOG and loans disbursed to qualified students with completed files and activated awards.

March 1 Scholarship application deadline for KCC Foundation awards for 2022-23 award year.

Mid-March Financial Aid awarded for Summer 2022.

March 30 Spring 2022 PELL grants, SEOG and loans disbursed to qualified students with completed files and activated awards.

April 8 Priority date: Required documentation for grant or loan assistance must be completed and submitted to avoid being dropped at the May 6, 2022 summer preregistration payment date.*

April 8 Last day to apply for a Spring 2022 loan.

April 20 Spring 2022 PELL grants, SEOG and loans disbursed to qualified students with completed files and activated awards.

May 6 Summer preregistration payment due date.

June 3 Last day to apply for a loan for 6-week Summer 2022 classes.

June 15 First date that 6-week Summer 2022 loans will be disbursed to qualified students.

June 17 Summer 2022 Financial Aid Eligibility date - be enrolled for all summer courses, including 8-week and late starting, by this date.

June 24 Last day to purchase books and supplies in the bookstore using an eligible PELL grant or loan, including all 6- and 8-week summer classes.

June 24 Last day to apply for a loan for 8-week Summer 2022 classes.

June 30 Last day to file a 2021-22 FAFSA; it must have a valid expected family contribution (EFC) amount from the federal processor.

July 13 Summer 2022 PELL grants, SEOG and loans disbursed to qualified students with completed files and activated awards.

July 27 Summer 2022 PELL grants, SEOG and loans disbursed to qualified students with completed files and activated awards.

Aug. 10 Summer 2022 PELL grants, SEOG disbursed to qualified students with completed files and activated awards.

Sept. 14 Final disbursement date for Fall 2021, Spring 2022, and Summer 2022 from all award sources.
